# Rental Restriction Update

Last year the board of directors worked with their attorney on proposing rental restriction for the neighborhood. With three sections of Seifert Creek, each of the sections needed to vote on the change. It takes a majority vote of owners for each section to pass the amendment. All three sections received enough ballots in favor of the rental restriction. Thanks to everyone who participated in the voting! Due to COVID, the finalized documents were delayed in getting filed.
